I. Call to Order

The Guam Council on the Arts and Humanities Agency's Board meeting was called to order at 3:07 p.m. by Mr. Francis Guerrero, Chairman of the Board. Chairman Guerrero was the only who attended the meeting in person. The following board members attended the meeting via Zoom.

Director Flores and Program Coordinator Manibusan attended the meeting in person, while the rest of the staff attended the meeting via zoom.

II. FY 2022 Grant Applications - Review and Board Action

Chairman Guerrero welcomed everyone and stated that the focus of today's meeting was only the FY 2022 Grant Applications. Chairman Guerrero asked that Director Flores give a preface of today's meeting, grant cycle and the funding available, etc. Director Flores stated that the rest of the agenda items; the review and approval of minutes, executive director's report and the financial report would be tabled until next meeting. She indicated that like last year, \$130,000 has been earmarked for the grants. From that amount, \$53,800 must be directed towards Underserved, \$10,200 for Arts-in-Education, leaving \$66,000.00 total available for grant awards for the following discipline categories: folk arts, media arts, performing arts, special projects, and visual arts. Director Flores remarked that there were no art-in-education applications submitted and added that application # 2022-021, Hilary Raigetal was moved from Folk Arts to Underserved. She asked that in looking at these applications today, please consider that CAHA will be making an announcement that ARP grant funding of \$123,000 will be available soon. This is a nonmatching grant, does not include fellowships and CAHA will follow the same process for review and selection of ARP grant recipients as what is done with our regular grant cycle. Any applicants that were not awarded an FY 2022 can apply for a CAHA American Rescue Plan (ARP) Act Grant, which includes resubmitting their applications to CAHA again. The application would have to reflect how it meets the ARP criteria. Mayor Gogue, stated that his first name was spelled wrong in the documents that were transmitted to him for his signature and it should be corrected to reflect "Jessy". Director Flores responded that the mayor's comments are noted and the necessary revisions will be made. Furthermore, she asked that the members say their name prior to speaking and if they are referring to applicant, please state only the application number, not the applicant's name for privacy purposes, as well as to avoid any confusion as to who is addressing the Board and the application being entertained at that time.

Chairman Guerrero stated that the applications will be presented by panels and asked that the respective chairman of each panel bring their committee's recommendations to the Board for consideration and action. He reiterated that the \$66,000.00 total available for grant awards will be applied for the following discipline categories: folk arts, media arts, performing arts, special projects, and visual arts. Folk Arts would be presented first and Chairman Guerrero turned the floor over to the Folk Arts Chair.

A. Folk Arts – Ms. Simone Bollinger, Folk Arts Panel Chair introduced herself and stated that she cochair the panel along with Mrs. Donna Kloppenburg. Ms. Bollinger reported that their panel reviewed 4 applications and recommended the following:

Ms. Bollinger added that they were all great projects. Vice Chairman Certeza asked whether the panel has seen samples of what the applicant is exploring in terms of coconut carving. Ms. Bollinger responded that yes, they have seen pictures. She remarked that the purpose of the fellowship it to encourage artists and to help them develop their skills. Chairman Guerrero asked if any of the applications that were recommended funding would apply to the ARP grant. Ms. Bollinger stated that she did not have any information on the ARP grant, aside from it being a relief program.

Chairman Guerrero asked Director Flores to speak about the ARP grants. Director Flores responded that Program Coordinator Jackie Balbas would be able to provide more information and the parameters of the ARP grants. Ms. Balbas informed the Board that this program is made possible by funding from the American Rescue Plan (ARP) Act of 2021 through the National Endowment for the Arts. These funds are intended to help support arts and cultural nonprofit organizations, nonprofits that have arts and or culturally based programming, and artists, as well as assist the field in its response to and recovery from the COVID-19 pandemic. The ARP Subgranting Program will be carried out the same way our annual grant cycle program is done. Subgrants to organizations will support its daily expenses and general operating costs which includes staff's salary, stipends or fees for creatives, artists, or contractual personnel for services provided for current existing activities and projects that are in line with CAHA's mission, as well as, to prevent, prepare, respond, and recover from hardships suffered due to the pandemic, so basically general operational support, and programs. Subgrants to individuals will enable them to carry out specific projects and activities such as the creation of work, workshops, and presentations with tangible outcomes that promote and support CAHA's mission and

help them recuperate from the pandemic. Mrs. Kloppenburg asked Chairman Guerrero for clarification as to whether can applicants can apply for fellowships through the ARP grants. Chairman Guerrero responded that fellowships could not be funded by ARP funds. Ms. Bollinger stated that application #2022-018 could fall under the guidelines of the ARP grants, however that would need to be assessed further.

Chairman Guerrero thanked Ms. Bollinger for her report and indicated that Media Arts would be addressed next.

B. Media Arts – Chairman Guerrero indicated that he and Mayor Gogue co-chaired the Media Arts Panel. Initially there were 8 applications under this category, but one applicant, #2022-027 did not submit all the required documents, such as a detailed budget breakdown, therefore was ineligible. The panel reviewed 7 applications, 4 were big projects and 3 were to produce CDs. The panel recommended the following

Note: Chairman Guerrero commented that CAHA could only support the creative aspect of the CD, not the reproduction.

Mayor Gogue commented that #2022-012, Danilo Pocaigue, also wanted to pay tribute or honor those recording artists that passed away during the pandemic, some because of the pandemic and how it impacted the recording artist community. The applicant was motivated by the pandemic to do this project. Chairman Guerrero asked that Special Projects be presented next.

C. Special Projects – As the Acting Chair of the Special Projects Panel, Mr. Ronquillo stated the panel met on September 16, 2021 via zoom. In attendance at the meeting were panelists: Dr. Judy Flores, Secretary Krise, Vice Chairman Certeza and Mr. Ronquillo, as well as, Director Flores, and Program Coordinators Balbas and Manibusan. The panel reviewed 7 applications and recommended the following:

Chairman Guerrero asked if any of these applications presented would be applicable to the ARP grant. Vice Chairman Certeza stated that applications #2022-009, #2022-010, and #2022-029 may be applicable to the ARP grants. He asked staff's assistance in verifying if these applications fall under ARP parameters. Director Flores stared that staff do that. Chairman Guerrero thanked Mr. Ronquillo and stated that Visual Arts would now be entertained.

D. Visual Arts – Mr. Zepeda, Visual Arts Chair indicated that his panel was comprised of a high school teacher/visual artist, a popular writer/visual artist and himself. There were 6 applications submitted under this category, however, 2 applications were ineligible because not all the required documents/materials were submitted. The panel reviewed 4 applications and recommended the following:

Chairman Guerrero asked Mr. Zepeda whether any of the visual arts applications could be recommended for the ARP grants. Mr. Zepeda responded #2022-0017. Chairman Guerrero thanked Mr. Zepeda for his report and indicated that the Performing Arts applications would be entertained next.

E. Performing Arts – Master Francisco Rabon, Performing Arts Panel Chair indicated that his panel reviewed 3 applications. The three projects have artistic merit and would impact the community. The panel recommended the following:

Master Rabon indicated that applications #2022-001 and #2022-004 would qualify for ARP funding. They are legitimate nonprofit organizations with 501(c)3 status. Their projects align with the CAHA mission of the promotion and preservation of the arts and have presented COVID back up plans. All 3 performing arts projects met the cash match and will impact the youth and young adults. Chairman

Guerrero informed that Board, that staff has brought to his attention that casting calls for auditions for Frozen Jr. has begun and been posted on social media since August, making application #2022-001, Margarita Dancel, Disney's FROZEN JR. Returns an ongoing project. Therefore, applicant is ineligible to receive funding support because the project was started prior to the FY 2022 project period which commences on October 1, 2021 and ends of September 30, 2022 and this disqualifies application #2022-001.

Director Flores stated that she calculated recommended funding amounts of the top 2 applications in each of the 5 disciplines, except for Performing Arts total \$66,000.00. The breakdown is as follows:

- 1. Folk Arts #2022-002 Ulitao, Inc. (\$10,000.00) + #2022-024, Justin Green (\$3,000.00) = \$13,000.00
- 2. Media Arts #2022-022 Kyle Mandapat (\$10,000.00) + #2022-023 Ruzelle Judicpa (\$8,000.00) = \$18,000.00
- 3. Special Projects #2022-016 Natalie Bejado (\$10,000.00) + #2022-010, Hagåtña Restoration and Redevelopment Authority (\$5,000.00) = \$15,000.00
- 4. Visual Arts #2022-003 Micronesia Climate Change Alliance (\$10,000.00) + #2022-007 University of Guam (\$10,000.00) = \$20,000.00

Note: Performing Arts' applicants #2022-001 and #2022-004 will be encouraged to apply for an ARP grant.

Mr. Zepeda clarified that the recommended amount for application #2022-003 should be \$8,900.00 instead of \$10,000.00 as Director Flores had indicated. CAHA funds cannot be use for cash prizes, so \$1,100 was eliminated from the budget. With that reduction, the panel recommended funding in the amount o \$8,900.00 for application #2022-003.

Vice Chairman Certeza recommended that funding for application #2022-010 be reduced from \$5,000.00 and that the funds focus more on artistry versus being used for logistical purposes He added that the value of this project is that it's different and they want to challenge the community by creating floats using recyclables and sustainable materials. The applicant could seek additional funding elsewhere.

Mrs. Kloppenburg stated since they are not mentioning names how would the Board know if there is a conflict. Director Flores responded that the members could refer to the FY 2022 grant listing that was distributed to the Board at the beginning of the grant process. She added that the list would be sent to the Board now. Mrs. Kloppenburg inquired about the fellowship application. Chairman Guerrero answered that it was included for funding support.

Mr. Ronquillo stated that the methodology was to fully fund the top 2 applications in each discipline which was the reason for the ranking.

Secretary Krise inquired whether applicant #2022-018, wants to reapply for an ARP grant. She stated that the hut building project was one of the best projects presented today and she is not comfortable with moving the application and suggesting that the applicant reapply for an ARP grant. Mrs., Kloppenburg echoed Secretary Krise's comments. Vice Chairman concurred with Secretary Krise. Ms. Bollinger stated that the applicant would need the in-kind and match and there is no guarantee that the applicant would want to apply for an ARP grant. Master Rabon expressed his concern on the sustainability of the project. He is aware of the applicant's skills, and recognizes importance of the transference of knowledge, but what will happen long term regarding the sustainability of the

individual conducting the apprenticeship program and organizations such as Gef Pa'go. Director Flores responded that this would have to be researched further. Mr. Ronquillo stated that grants are approved for the length of the project, and unfortunately, we can't keep track of everything after the project is completed. He added that he supports Secretary Krise and Mrs. Kloppenburg convictions to fund the hut building apprenticeship through the regular grants.

Chairman Guerrero stated that if the hut building apprenticeship with the other 2 folk art applications, the total for folk arts to \$22,000.00, along with media arts is \$18,000.00, special projects \$15,000.00, and visual arts \$18,900.00 bringing the total up to \$73,900.00. So, we are over by \$7,390. Ms. Bollinger and Secretary Krise suggested that the fellowship not be funded. Mrs. Kloppenburg strongly disagreed and asked that the fellowship for \$3,000.00 be reconsidered for funding.

At this time, Mr. Ronquillo recommended to fund ninety percent (90%) of the top 2 applications in each discipline, as well as, the hut building apprenticeship. That would bring the total over by \$510.00. Vice-Chairman Certeza recommended that the \$510.00 be taken from application #2022-010, Hagåtña Restoration and Redevelopment Authority for the 1st Annual Sirena Festival. Ms. Bollinger commented by underfunding a project by ten percent (10 %) across the board hurts the project and she would prefer one hundred (100%) funding support. Secretary Krise and Mrs. Kloppenburg concurred with Ms. Bollinger's statement. Several board members indicated that they had to leave. Mrs. Kloppenburg commented that more time was needed to discuss things further.

Mr. Ronquillo moved to approve that the top 2 applications in each discipline be awarded ninety percent (90% of their funding request) including the hut building apprenticeship and that an additional \$510.00 be subtracted from application #2022-010, Hagåtña Restoration and Redevelopment Authority for the 1st Annual Sirena Festival which will meet the threshold of \$66,000.00. Motion seconded by Vice Chairman Certeza.

Chairman Guerrero called for the vote.

Chairman Guerrero asked what was the staff deadline to prepare the necessary documents for the grants. Program Coordinator Balbas stated that the staff needs to prepare the notification letters, contracts, and invoices, as well as, have the grantees sign the document by the end of September so that the routing of the documents to the appropriate agencies can begin.

Chairman Guerrero stated that maybe more grant workshops for the next cycle should be held next year to assist potential applicants and improve the grant process. Mayor Gogue mentioned that 2 panelists volunteered to assist and conduct some of the grant workshops. They will be able to provide valuable insight and guidance. This will assist applicants in preparing their application and preparing a realistic budget.

With no further business to discuss, Mayor Gogue moved to adjourn the meeting at 5:50 p.m. Motion seconded by Vice Chairman Certeza.

IV. EXECUTIVE DIRECTOR'S REPORT – Director Sandy Flores

Executive Director Sandy mentioned that it has been a very good year at CAHA since the last board meeting. September and October mark's the end of the Fiscal Year as you all know for many projects and grants for both local and federal government funding. Our staff have been very busy in managing this work in doing the the requirement reporting applying for FY 2020 refunds. So, I want to THANK Jackie, Joey, Mark and Angie for all the hard work. There's has been great thing's in the work's that we've been able to announce the applicant's we are going to fund the FY 2022. We been also able to offer applications for our new round of funding for the American Rescue Plan (ARP) and we're ready to launch our workshops for Creative Aging, which is setting the groundwork for multiple projects around the island and to the community. Tomorrow is the soft opening for CAHA new Gallery Space and we have funding for more robust lighting and happy to report that our budget provided for a \$60,000 thousand dollars of gallery fixtures and improvements as requested and will get even better. The exhibit currently shown is entitled "Our Time, Our Place, Our Resilience" and it features a variety of artist's and mediums that represents our island in art produced around the time of the pandemic. Mark Dell 'Isola has provided three large pieces produced as result of the current 2020' CARE'S ACT Grant. Artist and CAHA board member Rolly Zepeda have contributed painting as well as a three-dimensional installation entitled "The Silent Warfare" We also had a loss at this time, Master Carver and former board member Frank Lizama passed away. We've been in conversation with the family and other government entities that want to mark his passing. And planning to install a tribute to Frank Lizama to the current exhibit and host signing a "resolution" in his honor on November 10, 2021 at 9:00 am at the CAHA gallery. We are really honored to do this and to show gratitude of Frank's Lizama's contribution to the traditional arts "Blacksmithing" on Guam. Amongst all these events and operational requirements. I want the board to be aware that CAHA is short staffed and in particular lacking an Administrative Officer. PC I, Joey Manibusan, is continuing to take on most of these tasks but it's not sustainable. And during his busy time all of us at CAHA will be learning new functions and taking part of the load. We are also reaching out to other agencies for help and they been very cooperative providing help when they can. I ask the board to be aware of the situation and to have patience with us at this time. "The Board chair asked about the announcement of a new position" the director responded that it will take new funding but the new full-time position may not be filled until Spring 2022. On a positive note, that we expect the ARP operational funding to be announced any day now and in a couple of weeks after that, there should be funds available and we can expect some of the funding to include support staff, a new vehicle and new podcast equipment and all with the goal of utilizing the new space to its fullest. In addition, two things we are working towards are: establishing the rules to utilize the percent funds and been working with the AGs office to accomplish this in an estimated 6 months' time. We are pursuing a design and proposal for a dedicated building for the Arts & Humanities on Guam in the next five years. So, I feel that CAHA has turned a corner as are now able to offer more to our new space. Unfortunately, our pace is slowed a little due to our staffing challenge, however I'm really encourage by the team spirit of our staff and I am confident that I will continue to move forward in bigger and better ways and really thank the board for their consistancy.

The material will be forwarded to the board after November 1, 2021 for board panel review. All applications will be grouped and categorized and be sent to the perspective panel members. This will be reviewed and discussed on the next board meeting on the November 23, 2021 for the approval and the announcements for the awardees. We would like to announce the awards by December 1, 2021, so that the grantees start and will have until September 30, 2022 to complete.

RELATIVE TO CLARIFYING THE AUTHORITY GRANTED TO THE DIRECTOR OF THE GUAM COUNCIL ON THE ARTS AND HUMANITIES AGENCY (CAHA) IN THE ESTABLISHMENT OF "REVOLVING FUND" ACCOUNT(S) FOR REVENUES COLLECTED AND/OR ACCEPTED BY OR ON BEHALF OF THE GOVERNMENT OF GUAM, FOR THE SPECIFIC PURPOSE OF SUPPORTING THE MISSION AND/OR OPERATIONS OF CAHA, IN ACCORDANCE WITH EXECUTIVE ORDERS AND THE LAWS GOVERNING THESE REVENUES THAT DIRECTLY SUPPORTS CAHA.

WHEREAS, Executive Order 84-3 authorized and provides the general guidelines pertaining to the establishment of a Revolving Fund for the Guam Council on the Arts and Humanities Agency (CAHA), which has been the current template used by CAHA; and

WHEREAS, the Guam CAHA, over the years, has established multiple Revolving Fund accounts in support of different CAHA Sponsored programs, and that these accounts are currently with the BANK OF GUAM, as follows:

- 1. Guam Council on the Arts and Humanities Agency Account No. 0101-304902,
- 2. Festival of Pacific Arts Account No. 0101-300627,
- 3. Percent for the Arts Account No. 0101-339916; and

WHEREAS, with a growing revenue stream under the *Percent for the Arts* program, the CAHA **Board** has determined that "unobligated" collected revenues should be deposited in to an "<u>Interest</u> Bearing" Revolving Fund saving account, until such time as the Board of Directors approves the obligation and disbursement of these funds, which will then be transferred back to the program's checking account for disbursement; *and*

WHEREAS, with the recent appointment of a new Director to CAHA, Board action has been requested in authorizing these new employees to assumethe duties as "signatories" of the established Revolving Fund accounts, in accordance with Executive Order 84-3; *NOW THEREFORE BE IT*

RESOLVED, that the **Board** approves and reaffirms, in accordance with Executive Order 84-3 and 5 GCA Chapter 85, Section 85104, that the following positions within the Guam Council on the Arts and Humanities Agency (CAHA) are designated to be "authorized signatories" for all Revolving Fund accounts:

- 1. Executive Director; and
- 2. Chairman of the Board; and
- 3. Program Coordinator IV; and be it further

RESOLVED, that the following person(s) are assigned as the "new" signatories for all CAHA Revolving Fund accounts:

- 1. Sandra S. Flores, Executive Director; and
- 2. Francis Guerrero, Chairman of the Board; and be it further

RESOLVED, that the "authorized signatories" will continue to comply with all Executive Orders and applicable laws governing these Revolving Fund accounts, to include, but NOT limited to the endorsement of two (2) authorized signatures on all issued checks; and be it further

RESOLVED, that the Director of CAHA is ordered to establish an "<u>Interest Bearing</u>" Revolving Fund Savings Account and to transfer unobligated *Percent for the Arts* funds, not to exceed <u>Eighthundred Thousand dollars and no-cents (\$800,000.00)</u>, in to this savings account, unless otherwise approved by the Board, via a duly adopted Resolution.
